§ 1

Definitions

Conference - The 11th International Conference on the European Energy Market 2014, taking place in the International Cultural Centre in Krakow on 28-30 May 2014.

Komuny Paryskiej 5a, 90-007 Lodz, entered into the Register of Associations kept by the District Court for the Capital City of Warsaw in Warsaw, XII Commercial Division of the National Court Register under the KRS number 0000214669, NIP 725-002-94-97.

§ 3

Personal details

1. Personal details of Applicants and Participants listed on the Conference Website are processed through this site, by the Organizer and SEP, for the purposes of the Conference, and in connection with the maintenance of the Conference Website.
2. Personal details given by the Applicant in the process of payment by credit card or bank transfer via PayU are managed by PayU company.
3. Each Applicant and Participant shall have the right of access to and correction of, their personal details under the rules provided by the provisions on the protection of personal details. Collection of personal details of Applicants and Participants takes place on a voluntary basis, however, providing this information is necessary to participate in the Conference.
4. Through Registration a Participant agrees to free use and dissemination of their image/voice for information-marketing purposes connected with the process of organizing the Conference, including advertising and promotional materials concerning the Conference. Consent is granted for an indefinite period and includes a license to use and distribute the Participant's image, his name and surname on the photographs, videos or recordings made during classes and meetings, appearing on the Conference Website. The expression of that agreement takes place on a voluntary basis.
5. The Applicant may consent to receive from the Organizer or SEP marketing information, by means of electronic communication, particularly e-mail, within the meaning of the Act on Rendering Electronic Services of 18 July 2002 (Polish Journal of Laws 2002, No. 144, item 1204 with subsequent amendments).

§ 4

Payment terms

1. The Conference Fee is dependent on the date of Registration, and its amount depends on the date of Online Registration. Detailed information on deadlines can be found on the Conference Website.
2. Paid Participant can pay via a credit card handled by PayU,
3. Applicants making Online Registration are entered to the list of participants after completing credit card payment and confirmation by PayU service. Applicants will be notified immediately and automatically by the Organizer via e-mail about the fact of either inclusion in the list of participants or refusal the right to participate.
4. In the case of Completed Registration of a Paid Participant a VAT invoice is issued within 7 days, which shall be sent to the office address provided during Registration Online and by email to the e-mail address provided during Registration.

5. In the event that an Applicant pays the Conference Fee and subsequently permission is refused by the Organizers to participate in the Conference, total Conference Fee will be returned to the bank account.

§ 5

Cancellation of Participation in the Conference

1. The Participant who makes an Online Registration has the right to resign from participating in the Conference at no cost until 10 business days after Registration and payment.
2. Cancellation of participation in the Conference must be submitted via e-mail sent to the e-mail address: contact@eem14.com or tomasz.siewierski@p.lodz.pl. The e-mail with the withdrawal notice must be sent from the e-mail address provided during registration. The resignation will be deemed effective upon receipt of acknowledgement of removal from the list of participants on the email address provided during Registration.
3. If information about the cancellation of the participation in the Conference is made effective within the period specified in paragraph 1 or before the end of April 2014, the Organizer will return 100% of the Conference Fee to the Paid Participant.
4. If information about the cancellation of the participation in the Conference is made at 1st May 2014 and after, the Organizer reserves the right the Organizer reserves the right to deduct 50% of the Conference Fee.
5. If information about the cancellation of the participation in the Conference is made 7 or less business days before the Conference starting date the Organizer reserves the right to deduct 100% of the Conference Fee.
6. A Paid Participant, may transfer the right to participate in the Conference to a third party with the Organizer's consent. For this purpose, they should report it to the Organizer by e-mail to: contact@eem14.com.

§ 6

Conference cancellation

1. In case of the cancellation of the Conference by fault of the Organizer or due to force majeure, the Organizer will return the Conference Fee in full.
2. To the fullest extent permitted by Polish law, the Organizer excludes its liability for damages incurred by participants in connection with the organization, the process, cancellation or postponement of the Conference. The Organizer is not liable for benefits lost by the participants in this case. In the event of multiple contractual liability and tort, the participant may seek compensation within the limits specified above, solely on the basis of the provisions of this paragraph.
